## **DES Report**: Beau Crowding

- Rebanding: Thanks for all the help, look to be completed in February.
- New Radio System: Moving forward, currently finalizing leases.
- Training Facility: Had meeting with contractors. Bid opening on Nov. 6<sup>th</sup>.
- Backup 911 Center: Flooring and ceiling going in. Consoles should go in starting in November.
- CAD: Starting next week with MDC layouts. July 2014 looking to have new CAD online.
- Paging: Working the interference issues with the FCC. Should see some movement soon.
- Regional Fire Sub-Committee Meeting: 2011-12 Money needs to get spent. Money will be broken out based on Risk Assessment of the 5 counties.
- Training: Background check training in early Nov. Being put on by HACC at the PSTC. There will be a strike team class in November. Fire Service Administration class to be held again in Feb '14.
