DES Report:

DES was tied up at a Incident in Malvern Borough and was not able to attend the meeting

- North Working on the Stand-By Knox Boxes for any Northern or bordering Montco station in need.
- **South** Working on regional SOGs for Structure Fires to expand upon the arrival assignments to include roles for Chief Officers and Standard Terminology.

- **EMS** Evacuation Kits distributed regionally in the need to evacuate a long term care facility. Harry working on getting them into the CAD as a resource. EMS Council looking into the impacts of JRH closing.
