Aprils Advisory Board Notes 04/07/2022.

DES Report:

- 14 Invest, 9 notifications, Hazmat 3 responses, 8 notifications for March. Hazmat team helped with the Peach Bottom Mon/Decon drill.
- Locution: working with Hexagon on track for Mid Summer for completion.
- MontCo Still doing testing. Ran into some issues accessing the Montco channels.
- New Routers Brief pause on new routers due to a GPS router issue. Antennas pulled and sent back to England
 for testing. Install are starting again and they continue to monitor the situation.
- VRM Router Swaps- Met with Devin and a policy is coming out.
- ACD Telecom Interference on Fire D1. Doing more testing, no findings.

Districts:

- North Met last month, working on having the Elected Officials and Apparatus Display at the May meeting.
- South Helmet standard colors (Interior/Exterior). Officer colors and shields still in progress.
- East Concerned about the porta thank requirement. They say to put in CAD and request it if needed.
- West Discussed difficulty with EMS. Still discussing the porta tank requirement, not in favor.
- Central Still talking about RIT Team and concerned about 49 being dispatched for both assignments.
- **EMS** In good shape. Working with one police dept that is requesting EMS dispatched for blood draws due to long ETAs to hospital. MCI Bus is still in progress. Looking to do a preview in May at Brandywine.
- Fire Police Nothing to report.
- RTF No Responses last month. Leadership met with DES, some grant money may be available for walkout boats. 8 Members taking structural collapse class. R53 going to Philly in April for Drill.
- FTF Responded to 21's junkyard fire. Drill cancelled for the FTF on the 23rd
