- IALS Level EMS Dispatch:
 - Effective 5/9/22 CAD will recommend IALS for the following ALS type codes: Back Pain, Abd. Pain, Diabetic Emergency, Injured Person.
 - For these ALS incident types, CAD will now recommend an IALS unit when the defined BLS agency(ies) has an IALS unit logged on and that unit is available. Otherwise, the default dispatch level will remain ALS when ALS is indicated.
 - o No IALS unit will be recommended by AVL for the above ALS incident types in lieu of an ALS unit.
