CCFCA Advisory Board Report:

- County Chiefs Recruitment and Retention Committee is meeting regularly
 - County Commissioners are supplying funding
- Committee is looking to apply for a County SAFER Grant
- The Octorara Cadet program is ongoing. Now with two sessions including a morning and afternoon classes. The Program is open to all School Districts in the County. Beau will send out information on the programs. It helps if the Fire Chief pushes the interest to the School District.

DES Report: Beau Crowding and Tim Hubbard

- Radio System coming to an end. Some minor issues still being worked on.
- Working towards a resolution on the SMUs
- Everything for Second Touch and Collar Mic swaps should be completed
- February 11th Chiefs update, Justin will be going over the CAD changes
- County has been out to some Townships to educate the supervisors on the capabilities of the new CAD.
- Chiefs Association is working with CCATO about funding questions.
- Training Campus: Construction is well underway and there is limited parking
- Firing Range will be done at the turn of 2017/18 with increased parking
- Firing Range will have classrooms that will be used by all disciplines
- The County will be hiring 30 part time event staff to assist with building operations.
- In June there will be an opening for a law enforcement training coordinator.
- Beau will be returning to WC to focus more attention on the Fire Service and a road map for the next 5-10 years.
- FM Report (Tim Hubbard)
 - o 19 responses for December
 - No Active Arson cases carrying over from December
 - One FF injury and no Civilian fatalities

Old Business:

- Evan brought up that Jay Pollinger is in charge of getting the 501c3 handled.
- Ridge had a check for the Gallagher Benefit that was not cashed. They would like to reissue that check to the appropriate name.

New Business:

- Valley Forge has merged with West End as an EMS division under the Fire Company Management

- Website Domain Changes: After the NCCFCA.org domain was hacked and stolen from the Association the group was all in favor to change domain to NCCFCA.com. Rich Hedrick (62) was going to move forward with getting the domain switched.

 NFPA Apparatus Standards to be revisited at the County Level. The group was in favor of entertaining the review of the standards.

- Montco: Limerick's fire station is underway, Royersford should be in their new station by the 1st, Linfield is looking to upgrade their Field Unit
