CCFCA Advisory Board Report:

- March's Advisory Board Notes Distributed
- Reviewed about the large amount of radio traffic during the March 1st wind and brush fire events
- Reminder to get your Enterprise Wizard Roster list up to date by end of March so proper allotment of pagers can be purchased. Some County Stations have listed over 100 members.
 - New Pagers are looking to be Non-Voice Swiss Phone Quad X Series Pagers
- CCFCA By Laws Committee is working on By Law revisions to define what a fire company is and what a municipal fire official will be as member of the Association.

DES Report: Justin McClure

- New Pagers/Paging System Tower Site Work had begun, Rebroadcast decommissioned 3/12/25. Enterprise Wizard Roster Updates are due by 3/31.
- Radio System: 3/1/25 West Fire had 2,129 Key Ups (Avg. is 818). There were 8,181 secs of Talk Time (Avg. is 2,707)
 - Agencies are reminded to avoid interrupting conversations and to limit traffic to necessary communications during periods of peak call volume.
- Tax Rebate: Notarized Eligibility lists and point sheets were due Feb. 15th. No exceptions
 - o 39 Agencies submitted eligibility lists.
 - 3 agencies who did not submit last year submitted this year
 - 3 agencies who submitted last year did not submit this year
 - Feedback was received and discussed with the Commissioners scheduling a follow up meeting.
- Rescue Task Force: Bill Cummings has started as the new USAR Program Manager at DES.
- PSP has requested a 24 hour hold on fire scene photos for incidents in their jurisdiction.

FM & HazMat Report: Justin McClure

- February 2025 Stats
 - o Fire Marshals; 11 investigations, 13 notifications
 - o Hazmat; 4 team responses, 3 duty officer responses, 1 notification

Old Business:

- County had floated the idea to the districts about DES funding a single responder based alerting system (I am Responding or Active 911) if all the stations could agree to go one a single platform.
 - After some discussion, Josh Spangler (69) made a motion and seconded by Jay Pollinger
 (61) to vote for I Am Responding as the platform choice of the North.

- Have we heard what the State Commissioner is doing for the reporting system software. Need
 to get better standards from the State on the reporting. Plays a big role when needed for
 Cancer Presumption.
- Website updates. Richard did make some changes. Any new changes that need to be made please help Richard out.

New Business:

- Ludwigs is going to host a Decision Making for Initial Company operations.
- Valley Forge is switching to a Passport Accountability system over the 3-tag system.
 - Will make it work with any mutual aid they respond with.
- Pete Hornsberger (69) asked does anyone's municipality have an ordinance for tree trimming on personal driveways.
 - It was discussed to also loop in bridge and gate access as well.
- Governor has in new budget proposal for a competitive grant program with 30million in funding, Projects ranging from 250,000 -1.5million. Criteria and Grant rules still being worked out.
- Discussed the use of Building Fire Type Codes for incidents that may have been better suited for Electrical Fire Inside during the February 15th Wind Event. Also heater malfunctions are supposed to get the Appliance Fire Type Code.
 - The Group proposed asking for a Smoke in the Building Type Code to be looked at as an option for Fire Companies to have a tailored response for over a Building Fire response.
 - DES does stress it's based on the lack of information they receive by the callers.
 - Further review of the criteria for house fire type codes. What questions are being asked.
 - Adding a Smoke in the Building –
 - Electrical Fire Inside vs full box. What is the criteria? Supervisors overriding.
 - 3/12 Valley Forge House Fire Heater Malfunction
 - 2/16 Kimberton House Fire, and Norco Building Fire.

Good of the Company:

- Montco Report: Limerick is hosting a Command Structure 4/21st
- Abington Response from Chester County was low.
 - o They asked to fill out 12hr shifts. Smaller shifts may have been easier to fill.
 - Chiefs were not given a lot of time, before they moved on.
 - Testament to the daytime volunteer shortage.
- Jonathan's Father, Wayne, passed away on Tuesday, March 11th after a lengthy hospital stay. Services are Saturday, March 15th at St. Basils Church in Kimberton.
- May's Meeting will be at Ridge Fire Co. on May 14th.
- State Elected Officials are planned for May's Meeting.
